# Tribal Manager/Administrator Report to Council - October 19, 2024

# **Grants Update:**

# <u>Assistance Programs:</u>

- American Rescue Plan Funding: Implementation for the following program initiatives have continued.
  - o The 2024 \$750 Utility Assistance phase 4 program began in January. To date we have provided \$41,034.54 in assistance. \$38,784.54 in payments made to utility companies (74 checks issued) and \$2,250 for UTV fuel (3 payments). A total of 57 Tribal Members have received assistance.
  - The new 2024 ARPA \$2,500 rental assistance: To date we have provided \$110,290.00 in assistance to 54 Tribal Members. A total of 84 payments have been made.
  - o Housing Improvement Program To date 34 Tribal Members have received assistance. 76 payments have been made and one to UTV for lumber. Total outgoing payments: \$308,936.22.
- BBEDC Block Reimbursement Requests
  - $\circ$  FY 2023 \$22,596.68 for labor and materials for the Flying D.

#### Current balances of the open grants are as follows:

o **2020**: \$5,066.40.

o 2022: \$251,781.25

- **BBEDC Arctic Tern:** I am in the process **of completing** the final report.
- **BIA ICWA:** 4<sup>th</sup> Quarter report has been submitted.
- **EPA IGAP:** Betti will have an update on her report. .
- **BIA ATG:** I am currently working on the paperwork needed for our third year of the three year contract. It will be submitted to our BIA officer early next week.
- **NAHASDA** We are processing applications and making payments to qualified Tribal Members.
  - FY22: 39,388.50 budgeted. \$35,449.65 for rental assistance vouchers and \$3,938.85 for admin in-direct costs. \$16,510.00 has been spent on assistance. 24 payments 7 families served.

FY23: 39,858.00 budgeted. No change since last month's report. \$32,358.00 for rental assistance vouchers and \$7,500.00 for admin. Total funds expended Jan - August: \$9,750.00. Seven families have been served. 12 Checks issued

# **Projects:**

- **Health Aide:** Timothy Villar is asking for a letter of recommendation. If you have any input to his work this past summer.
- Audit Now that the 2021 audit has been closed. Pete continues to work on 2022 2023.
   Betti, Clementine and I have been getting information, documents and files to Pete.
- Flying D Landing Craft: Larry will have details.
  - The Flying D is on its way to Pilot Point and then will be in Ugashik. Lary will have exact dates.
- Lake & Pen Grid Resiliency Funding: Nothing new to report. The application was submitted by Lake & Pen. I am waiting to hear back from Kate Conley on its status. We have discussed the possibility of the following projects:
  - Fix and/or upgrade existing generators
  - Install/repair batteries
  - Upgrade existing wind turbines
  - Add new batteries or upgrade existing Community Center and Equipment Bldg
     Hybrid system to provide power to the new equipment bldg..
- **2024 Spring/Summer Projects: Nothing new to report.** The following projects have been discussed for implementation in 2024. Additional discussion and ideas are encouraged.
  - o Community Center: New Carpet and flooring.
  - New gravel site: Conveyer belt is in the process of getting shipped to from Naknek.
  - ARPA Hybrid Energy Systems: Larry will have updates on the status of each.
  - ARPA Water Improvement:
    - 12 wells were dug, including the Covid House and Community Center.
    - o The community center well needs new power.
    - Pump setups for Julie, John Ruhl and Tim were completed, but they still need to get converted to 120.
  - Septic Upgrades: We have earmarked \$325,000 from ARPA for this.
  - o Fuel Depot: The Following have been completed:
    - o Get connex moved to new layout (Larry) Done
  - Fuel Tank Depot Housing Unit: A new building covering the tanks and containment has been completed. Pictures are in your packet of materials. - Done
  - New Equipment Bldg: The new loft has been built. Done
  - o **Road to the Win-Ray:** This project has been tabled until 2025.
  - Disposal work on Win-Ray: Tabled until 2025.
  - Fuel Truck: The new fuel truck is in the village Done
  - Caribou Cabin/Covid Isolation House: I will have update at the meeting
  - o **Trencher -** This has been delivered and is in the village.
  - Purchase Rock Crusher No updates yet.
  - Extend Landfill: Eddie finished this project

- 3.5 Furthering development of gravel pit for use in village
- 4.2 Working on Septic funds supplied by ANTHC for 2 homes
- 4.3 Working on Hybred energy systems.

## hazcom and safety plans

Moved equipment into blue building for winter storage

I will be finishing plumbing this coming year on Fuel depot to make it functional and safe

Village will need to have CPR refresher in 2025

#### solid waste management plan

BRIC grant with Bristol Environmental to ask village members for input on Tribal Hazard Mitigation Survey. I have the survey in office. At this time we have not had it filled out.

We got funding for Nancy and Mikey's septic systems. We are now in the design phase.

I will be working on new funding grant for Solid waste transport location using Barge landing, This could be another big game changer – Talked to Steven Price, 3 – 4 connex' down at the barge landing, backhaul, lighting, power – Steven Price, create a building, 250k – 500k, Letter of Interest deadline is March 26<sup>th</sup>. Julie asked about this. Fred stated there is assistance for Grant Writing from BBNC.

#### air quality and Dust control

Fire truck drained and put away

The village road is somewhat potholed, the village needs to address this next year. Ideas????

#### Ongoing projects and concerns

I was in the village in October to work on existing projects, repairing Hybred systems, working on Landfill and barge landing,

Still waiting on info on wells assessments and voltage conversion. (STILL)

Filled villagers and pumped one of the fuel trucks for use this winter.

Need CPR next year for village.

Working on AGS next year contact and closing out this years fuel use and responsibilities.

Allen contracted the boat for 2 months.

Rented our compactor to Pilot point for over weeks

Allen picking up compactor this Thursday or Friday 17th or 18th

Allen dropping off trailer, conveyor, compactor and wood package to village after he picks up compactor from Pilot point.

After boat comes home to seward we are getting it shrink wrapped so we can have maintenance done without snow issues.

Planning on rebuilding both 871 engines in boat, also rebuilding front hatch beneath ramp wench, rebuilding fish holds

## **Training & Conferences**

ATCEM and AFE is coming up and we "Dolli and I " plan to attend.

## **Questions to Larry:**

- ? Betti asked about E&E payments, Larry said it's been challenging and there is questions about fuel. In negotiations right now.
- Fred asked what is the "wood package"? Larry stated he's not sure, he knows Eddie picked up a package, he thinks for Wesley, and asked Mikey to confirm, Mike stated they unloaded the compactor, trailer that Allen was using, the conveyer belt, a couple stacks of pallets, lumber and plywood and Wesley had some tin and 2x4s for his roof and Mike had a box.
- Paniel said an idea for the roads, he stated a lot of us have gone through and filled the potholes up and compacted them down and obviously that only lasts for about a month maybe and they come back, they can get that done in a day, but to do it correctly, you have to dig the potholes out and then refill them so they don't come back. They might have to be refilled again once it settles, but that's a better way for them not to come back over time, by digging them out first and refilling them. Larry stated that he's still waiting for the State of Alaska to find out when they are going to sell the grader, with the grader they have potential to do that maintenance for the road, at this point they have not told him and he has not found it online for sale. He further states, once we have been able to secure the grader, we need to have someone who is confident enough to regrade the road or at least start working on it with the compactor.
- ? Mike stated that Courtney stated he could do the roads, no problem. He said, also we need to have that loose gravel on the runway pulled back. He said the roads are major, the airport is getting bad, the roads are really bad, don't need speed bumps because the potholes will slow people down. Larry said if we extend the runway, we would have the gravel and be able to do it all at one time. Larry stated we need to extend the runway so we can have larger aircraft.
- ? Fred asked if the DOT said they could extend the runway, 1,500 feet onto the runway, Larry stated the DOT should be able to help us, we have about \$100,000 in an account

- specifically for our runway. Larry believes we can get a waiver and be able to use our own gravel, sell it to the DOT instead of them having to bring it in.
- ? Mike asked when the work on the boat will start? As soon as it's in Seward? Larry stated yes, that's his hope, as soon as it's in Seward they will shrink wrap it this will keep the snow off of it and allow them to work. They will need to work on the engines and front hatch as soon as they can. Mike stated, yes, so he can get out in the spring and be able to begin the tendering on time so the boat isn't losing thousands of dollars a day....
- Fred asked what the cost of the repairs for the Flying D, Larry stated it starts at about \$100,000.
- ? Steven stated since the boat is going to cost a significant amount of money and there isn't a revenue stream that would support the cost outside of that outside of the block grant, we need to talk about priorities for 2025 block grant, the Flying D can become the major construction project, currently there is a line item for M&O but not to that level.
- ? Hattie stated that we all talk about the Flying D in the red, however, we have saved THOUSANDS of dollars in freight by using our boat. Mike stated he agreed and that was a good point.
- ? Julie asked about the new funding grant for solid waste, Larry stated he talked to Steven Price from DEC, he looked at this SWIFER grant potential the low \$100,000 and high is \$1.5m, he was thinking about a reclamation transfer station, he talked to Steven and Steven came up with guidelines that would be beneficial to the village. Looking at a building with a concrete floor, bailer, hybrid energy system, looking at \$250,000 to \$500,000 to set this up. Letter of Interest deadline is March 26th. Fred stated there is assistance for Grant Writing from BBEDC.
- ? Daniel asked if we get the (funding.....) new bailer and fuel farm, it would be basically across the street. Daniel asked if we could use the big generator that we are currently not using, Larry stated that he would like to get a hybrid system, go for the whole enchilada.

Hattie stated she thought we were going to give residents a choice on whether to get a septic system, upgrade septic, composting or incinerator toilets. We just need to know what to do with the composting toilet they have on hand right now. Fred suggests having a drawing during the working session.

Fred asked about fire blankets, Larry stated they are in the village, Fred stated, let's get them passed out next year.

**10.a. AFN Reports - All:** Steven stated he met with the Alaska Tribal Spectrum people, we are involved in four of their grant programs and has info from them and they can be in attendance at our next meeting and present and explain in more detail about what we can have with broadband. Discussed having them come to our workshop or council meeting in December.

Daniel stated this was his first one and he enjoyed it, some of the info he had heard when he attended the BBNA meetings.

Julie stated she enjoyed it and learned a lot.

Hattie stated she talked with Navy people and they have fisheries research projects, one is the tagging of chum salmon in the gulf.

John stated he enjoyed the meeting and spent time downstairs with the artists. John explained that he works as a curator of indigenous arts at the Anchorage Museum.
